Project Development Objectives

Project Development Objective (from Project Appraisal Document)

The development objective of the project is to facilitate access to employment opportunities in the garment sector for poor and vulnerable women from lagging areas of Bangladesh by providing information, technical and life skills training, transitional housing, and other support to adjust to urban life and formal sector employment.

Implementation Status and Key Decisions

All three DTCs are fully operational, with the designated number of management, training, security, catering and support staff deployed at each site. The training program started in August 2016 at all three dormitories and training centers (DTCs). While there was a requirement for 300 trainees per DTC, totaling 900 per session, Shushilon (the NGO hired by BEPZA, responsible for recruitment) received applications and registered over 1100 girls, putting the extra numbers in a waiting list. However, the number of potential trainees applying, registering and then actually arriving at the DTCs has steadily declined, despite high demand for their skills at factories and advanced job-placement offers (please see Annex 4 for specific data). The issues related to the above are described below. The Ministry has extended full cooperation and played a proactive role in coordinating with Shushilon in the field to bolster the recruitment figures; however, it was noted that Shushilon was often too late in informing the Ministry for the required assistance. The mission strongly recommends better coordination between MOLE and BEPZA in this regard and better supervision of Shushilon by both agencies.

During the first batch the job placement aspect lagged significantly. Trained girls returned home instead of waiting at the DTCs for jobs to become available, and most did not return when called to join work once those were available. This, added to the initial delays in starting the training program after the girls had been registered, created a significant negative impact on the project's credibility as well as that of Shushilon, the latter being a critical ingredient for the success of the recruitment process. The recruitment for the second batch showed a significant slow-down and Karnaphuli DTC remained closed due to lack of trainees. However, the quality of trainees was observed to be much better than the first batch; on the job performance of the trainees (for the small numbers that stayed on in jobs) was lauded by factory owners, prompting a significant jump in job offers.

During the recruitment process for the third batch more slow-down was noticed. This time Dhaka DTC remained closed due to lack of trainees. After the Bank firmly objected to Shushilon's performance and threatened to cancel their contract, they managed to mobilize and recruited approximately 200 girls for Dhaka DTC within a week. Bank deployed individual consultants and consulting firm monitored the field activities of Shushilon closely during this stage. However, the recruited girls were turned back from the buses ready to transport them to Dhaka, by BEPZA, due to a miscommunication according to the latter, and Dhaka DTC remained closed for the entire session. This has caused further lack of credibility for the project among potential trainees.

It has to be mentioned that, although the number of trainees has been well short of the target, the training quality has been highly lauded by factories and employers. There are approximately 8000 jobs lined up currently with the project Job Placement Service providers.

The Bank is trying to facilitate the creation of a CSR Platform for the project and secure CSR funds; but this has been particularly challenging given the results described above. In the meantime, saved IDA resources will be used until CSR Funds are available. Alternative funding sources are also being explored.


