Implementation Status and Key Decisions

This ISR is based on the findings of a mission which took place from 21 to 29 September 2017, and which included site visits in the commune of Keur Macen. The conditional grant component keeps progressing well and more than 200 sub-projects have been delivered. The partnerships with government institutions are now under implementation. The Strategy for Decentralization, one essential piece to maximize the results of the projects, is currently being procured and should start in December or January.

Results achieved so far include: (i) 65 participating LGs eligible to the Performance Grant; (ii) 630,000 people benefiting from the project compared to the end of project target of 456,000; and (iii) 440,000 person-days employment created under LG's sub-projects. This had led to the completion of 240 sub-projects (essentially classrooms and health centers, as well as markets) and 230 additional sub-projects are currently under construction.

The next supervision mission will take place in February 2018.
