Amendment No. 1 to the Supplemental Agreement between the Republic of Italy, acting through its Ministry of Foreign Affairs and International Cooperation, and the International Bank for Reconstruction and Development and the International Development Association regarding the Multi-Donor Trust Fund for Mainstreaming Disaster and Climate Risk Management in Developing Countries

(Trust Fund No. TF072584 parallel to original Trust Fund No. TF072236)

1. Reference is made to the Supplemental Agreement between the Republic of Italy, acting through its Ministry of Foreign Affairs and International Cooperation (the “Donor”), and the International Bank for Reconstruction and Development and the International Development Association (collectively, the “Bank” and together with the Donor, the “Parties” and each a “Party”) regarding the Multi-Donor Trust Fund for Mainstreaming Disaster and Climate Risk Management in Developing Countries (Trust Fund No. TF072584 parallel to original Trust Fund No. TF072236) (the “Trust Fund”) effective as of December 14, 2016 (the “Supplemental Agreement”).
2. The Bank acknowledges that the Donor agrees to provide, through the Italian Agency for Development Cooperation (AICS), the sum of two million Euro (EUR 2,000,000) (the “Contribution”) for the Trust Fund in accordance with the terms of the Supplemental Agreement.
3. AICS shall deposit the Contribution in the currency specified in paragraph 2 above into such bank account designated by the Bank not later than two (2) months following countersignature of this amendment (the “Amendment”) and submission of a payment request by the Bank.
4. When making a deposit, AICS shall instruct its bank to include in its deposit details information (remittance advice) field of its SWIFT deposit message, information indicating: the amount deposited, that the deposit is made by the Donor for Trust Fund No. TF072584 (the Multi-Donor Trust Fund for Mainstreaming Disaster and Climate Risk Management in Developing Countries), and the date of the deposit (the “Deposit Instructions”). In addition, AICS shall provide a copy of the Deposit Instructions to the Bank’s Accounting Trust Funds Division by e-mail sent to tfremitadvice@worldbank.org.
5. Additionally, the contact information of AICS in paragraph 6 of the Supplemental Agreement is amended to read as follows:




6. All other terms of the Supplemental Agreement shall remain the same.
