Preparation of Hydropower and Transmission Line Investment Projects: NEA is currently shortlisting the candidates for Engineering and Construction work for Upper Arun and Ikhuwa Khola Hydroelectric Projects. NEA is working on the RFP document for the Engineering works. Similarly, NEA is working on the EOI document for Environmental and Social studies work.

Studies and Preparation for Policy Recommendations and Sector Reform: WECS has started the procurement process and is ready to publish the EOI for River Basin Planning and Hydropower Master Plan study.




