

Implementation Status Overview

Additional financing by the Solomon Islands Government has provided sufficient funds for the project to be on track to achieve a significant proportion of its targets. Approximately 75% of community infrastructure beneficiaries (Component 1) and approximately 60% of the increase in recipients of agricultural extension services (Component 2) can now be reached. The target number of rural businesses receiving supplemental equity financing (Component 3) has already been achieved. Proposed additional financing would allow these targets to be fully achieved.








