Implementation Status and Key Decisions

The project is in its fifth year of implementation and has disbursed 67.6 percent of loan funds (for both loans combined). The project was restructured in June 2017 to reflect the reorganization of the project's implementation unit and the change in the Implementing Agency's name. The amended loan agreements were signed by the Bank and the Borrower in June and July of 2017 respectively. The Borrower fulfilled all internal procedures preceding the effectiveness of the loan amendments and based on the evidence provided, the Bank has declared the loan amendments effective on August 17, 2017. The component 1 (civil works) is progressing satisfactorily. Originally, the project envisaged rehabilitation of about 360km of lifeline roads. As of October 2017, rehabilitation of 272 km of lifeline roads had been completed, and 121 km of road sections were selected for rehabilitation in 2018-2019 project investment years. These bring the total number of km to be rehabilitated under the project to about 393 km.


