
Implementation Status and Key Decisions

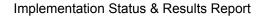




