# Implementation Status and Key Decisions



**During the second half of 2017, the Social Registry** continued its deployment throughout Mauritania. By now, 53.000 households are recorded in the Social Registry database (community targeting phase completed), of which 59 % are with complete data (household data collection phase completed). The annual work plan adopted in November 2017 schedules to target 14 additional moughtaas during 2018, bringing the cumulative households number to 100,000 by the end of 2018 (out of an objective of 150,000 by 2020).

A meeting with the organizations using the Social Registry (Food Security Office, Oxfam, WFP, Tekavoul) was organized in October 2017 and the feedback was satisfactory. However, the Social Registry needs to strengthen its external communication in order to better inform on its modalities and added value and encourage more social programs to use it.

**The Tekavoul program** has begun the scaling-up phase of its activities. After M' bout (the first moughataa targeted) in December 2016, the program reached Kankossa in September 2017 and Sellibabi in December 2017. The work plan approved by the project steering committee aims to deploy the program in six additional moughtaas in 2018 (Barkéol, Ould Yenge, Koubeni, Tintane, Aleg and Rkiz). This would bring the total number of households benefitting from the program to 38,000 by the end of 2018.

Data collection for the baseline impact assessment of the Tekavoul program began in December 2017 and the productive measures (ASP component) will start at barkeol and Sélibabi as soon as the data collection ends (January 2018).

Following the collaboration agreement signature between Tadamoun and the Food Security Office in July 2017, **the Shock-responsive safety Net Program** was implemented during the end of the lean season (August to October 2017). The program used social promotion tools (Social Registry, Tekavoul payment platform) to provide cash transfers to 1,014 vulnerable households. In 2018, the project will support a new implementation phase of the shock-responsive program in drought-affected areas. It will also support the program structuring (implementation of a MIS, grievance mechanism, communication plan...).

This ISR follows a world bank supervision mission led in Octobrer 2017. The next mission will be held in March 2018, and will organize a Mid-Term Review for the project. A Mid-term project report will be prepared to lay out issues met in implementation, as well as changes proposed to the project, and will be used as a basis for the discussions during the review.


