The development objective of the project is to facilitate access to employment opportunities in the garment sector for poor and vulnerable women from lagging areas of Bangladesh by providing information, technical and life skills training, transitional housing, and other support to adjust to urban life and formal sector employment.

Implementation Status and Key Decisions

After protracted delays (two years) at BEPZA, the Bank engaged with the Prime Minister's Office (PMO) over the last year to give guidance on a way forward for the project. At the last meeting held at the PMO on October 25, 2015 it was decided that a) The Bangladesh Export Processing Zones Authority (BEPZA) would continue as the main implementing agency for the project and would not deviate from the project objective or overall design; the Ministry of Labor and Employment (MOLE) will continue as the line Ministry; b) IDA would fund the operating costs of the project in a phased manner (100 percent in year one of operations i.e. 2016, 50% in year two until Corporate Social Responsibility Funds can take over from year three). This is as per the PAD agreed upon at Negotiations; however there was a disjoint with the Financing Agreement (FA)that states that all expenses have to be borne by BEPZA from day one. The FA will be amended during Restructuring; c) the issue of finding jobs and placing the NARI graduates therein was the sole responsibility of BEPZA and jobs were to be secured within the Zones. BEPZA has been consistently raising concerns regarding bearing this responsibility for the last two years. The agreement at the PMO was that job placement will be a shared responsibility between MOLE and BEPZA, with MOLE taking the lead in facilitating the process with the Bangladesh Garments Manufacturers and Exporters Association (BGMEA) as a partner. BEPZA factories will be the first preference, any spill over graduates will be placed at BGMEA factories; d) the Bank will facilitate the process of building a CSR platform under MOLE with BEPZA and BGMEA and in partnership with major buyers from Bangladesh as well as factory owners to generate the funds for the operating costs of the project for the last one and half years; e) the project will be extended till December 2018 to allow for it to meet its target of training and placing into jobs10800 girls within three years (it had previously been extended till October 2017 from the original closing date of December 2015); f) BEPZA would immediately submit a revised DPP to MOLE incorporating all changes and MOLE would then submit it to the Planning Commission for review and approval. MOLE, BEPZA, the Economic Relations Division (ERD) and the Planning Commission were all represented at the meeting by high level officials from each organization.

The DPP was submitted to the Planning Commission on November 26, 2015. A review meeting has been held to address minor queries and the DPP approval is expected within a week. The Bank is awaiting a request for restructuring from ERD in order to officially start the process on our side. In the meantime all pending key procurement packages have been completed and the training is expected to start by the first week of January 2016. Given the proposed revised closing date of the project (as per revised DPP and the shortly expected request for restructuring letter from the government) the PDO will now be achievable within the proposed revised timeframe.


