Implementation Status and Key Decisions

The World Bank Board of Executive Directors approved the US\$21 million loan for the Third Public Sector Modernization Project (PSMP-III) for Armenia on September 30, 2015. The Loan Agreement was signed on November 18, 2015 and the project became effective on May 6, 2016. PSMP-III will further assist the Government of Armenia (GoA) in its on-going efforts to improve quality of the public financial reporting and to improve access to selected enhanced e-government services. PSMP-III includes three main components:

- 1) Public Financial Management Information Systems;
- 2) e-Governance Solutions for Improved Service Delivery; and
- 3) Capacity Building and Small Capacity Building Interventions.

The project experienced issues related to timely commencement of a number of planned activities due to various fiscal, regulatory and capacity constraints, which are mostly overcome. As of December 2017, the project succeeded in initiating several tasks, most importantly (i) development of e-Consulate System, and (ii) technical assistance on strengthening policy and institutional setup of e-governance management in Armenia. The project team currently prepares procurement of pre-trial case management system for investigative agencies, a platform for electronic citizen feedback on public services, and electronic modules for emergency police dispatch and electronic traffic accident documentation system.
