SCALING UP EDUCATION FOR HEALTH PROFESSIONALS IN AFRICA CONFERENCE

IFC Headquarters, Washington, D.C.

IFC and the World Bank¹, in conjunction with the Global Health Workforce Alliance (GHWA) and Capacity*Plus* (USAID), will host a two-day conference to discuss some of the critical issues surrounding the production of health professionals in Africa and the potential contributions that could be made by greater public sector engagement with private and non-governmental institutions.

According to the World Health Organization, 36 countries in Africa are facing a critical shortage of health workers, which threatens to undermine the achievement of health developmental goals. There is now general consensus that unless this shortfall of health personnel is addressed, the health-related Millennium Development Goals (MDGs) and other population targets will be difficult to achieve by 2015. As a result, major investments by both the public and private sectors would have to be made in training teachers, strengthening infrastructure, improving pedagogical material and overall quality of the education process to meet desired targets.

The event is an important step by the World Bank Group and its partners to move this important agenda forward. It will showcase lessons learned in Ghana, Mali, and Kenya and will create an opportunity for African government officials, deans of training institutions, WBG colleagues, donors, and investors to learn about the issues and challenges surrounding the production of human resources for health (HRH) in Africa. Emphasis will be placed on identifying concrete steps and innovative approaches to mitigating the situation.

Investing In People: Scaling Up Education For Health Professionals in Africa

Specifically, the objectives of the conference are to:

- Deepen understanding of the challenges and innovative approaches which are needed to accelerate the training of skilled health workers in Africa.
- Review the historical context surrounding the training of skilled health professionals in Africa (Francophone and Anglophone experiences).
- Identify key milestones in the three countries.
- Identify impediments to rapid expansion (e.g., policy, resources, innovations, etc.) and sustainable solutions.
- Discuss successful business models in the three countries, the role of the private sector, and key lessons learned.
- Review role/performance of development partners in both traditional and innovative financing.

The event will provide African participants with the opportunity to:

- Share African perspectives and experience: challenges, opportunities, and options.
- Share lessons on successes/failures in both public and private sectors.
- Role of private sector, business approaches by public institutions (including PPP).
- Network with other participants.
- Discuss next steps and the level of political leadership needed to accelerate training of HRH.
- Initiate preparations for the upcoming regional conference to be held in Africa in September 2010 on the training of health professionals.

SESSION BRIEFS

Financing: Session will focus on new and innovative funding mechanisms that could be used to complement existing scarce public resources.

Business Models: Session will focus on sustainable business models and public-private partnerships that could contribute to the agenda of scaling up the education of health workers.

Governance: Session will discuss governance arrangements used for public, private, and non-governmental institutions engaged in the production of health professionals. Attention will be given to the aims of education, models of governance, and ways to strengthen oversight responsibility and stewardship in the production of health professionals.

Role of Donors: Session will review and discuss the role of donors and development partners in addressing HRH training in Africa and identify ways to improve gaps in knowledge, policy, and funding. An action plan for future donor involvement will also be discussed.
